Kingsbury Hill Release and Indemnity Agreement

I understand that the care and use of saddle horses including but not limited to maintenance and riding is a unique activity and, as such, carries with it the potential for severe injury or death. By my signature, I acknowledge the unique nature of this activity, the potential for injury or death and certify that I have no knowledge of any physical or mental impairment that would adversely impact my participation in equestrian activities. I accept full responsibility for all harm that may come to me or my horse or property. I further understand and agree to wear protective headgear when riding. When jumping, I agree to wear protective headgear with a harness attached that meets standards currently imposed by the U.S. Equestrian Rules for Eventing while mounted on a horse at Kingsbury Hill. (Helmets passing or surpassing the ASTM/SEI standards are strongly encouraged when jumping) I understand it is required to wear body-protecting vests during cross-country while at Kingsbury Hill. I release and hold harmless Kingsbury Hill, LLC from any and all responsibility from financial loss and expense, including reasonable legal fees and costs, if any, arising from injury to me or my horse and damage to my property as a result of participation in such activities.

Further by my signature, I agree to indemnify and hold harmless Kingsbury Hill, LLC from financial loss and expense, including reasonable legal fee and costs, if any, arising out of any and all claims, demands, suits, or judgments by reason of accidental injury to a person or accidental damage to property as a result of my participation in equestrian related activities or as a spectator.

If a participant is under 18 years of age, a parent or guardian of such a participant shall sign this agreement on his or her behalf.

Under New Hampshire law, an equine professional is not liable for an injury to, or the death of, a participant in equine activities resulting from the inherent risks of equine activities, pursuant to Revised Statutes Annotated, Chapter 509:19.
